

The first time I saw Genevieve, she was sitting on the side yard of Mrs. Sonntag's house on the corner of Seventh and Union streets, her long blonde hair tied back in a pony tail, scooping out some weeds with a forked trowel. I felt for the woman for two reasons: one, the working conditions, that is, the steep slope of the hillside left over from the cut to make Union Street many years ago, and second, the job itself, a thing I simply cannot do.

My hand can hold a hammer, but it cannot dislodge a dandelion. My grandfather ruined me for that work by making me weed my childhood backyard after he moved in with us in San Diego. It was a huge (to me) backyard which had been there for who knows how many aeons of geological time, giving nature's toughest weed species the opportunity to settle into the concrete-hard clay with re-bar caliber roots.

I hated pulling weeds with a teenager's bottomless self-pity mingled with deep resentment towards my authoritarian grandfather whom I respected, but when he moved out, I was glad. (So were the weeds. They got a lifetime reprieve, at least from me.)

Genevieve worked for Mrs. Sonntag, my 83-year-old neighbor. The elderly lady and I shared a driveway with two other homes. Recently I had completed Mrs. Sonntag's home, that is, the building itself, leaving the landscaping to others.

The young woman working down there, dressed in baggy clothes and sitting in a cross-legged yoga position, was, I figured, Mrs. Sonntag's "others." Having worked with this feisty woman for months building her house, I knew that she was perfectly capable of finding good help when she needed to after her husband passed away just after completion of the house.

My own house up the driveway was also in need of landscaping, or at least of someone who knew what they were doing in that department. That was not me. I'm not good with plants. Buildings I

understand, but anything organic I leave to others.

My house is shaped in an L. The part that sticks out, the longer side of the L, is a loggia that leads to the front door. Did I say "loggia"? That's a stretch, since there was nothing much to look at through the columns of this "loggia" although I had tried a couple of ideas.

The extension making the rest of the L, the shorter wing, is the south-facing kitchen with a great view. The carpenter who built the house decided it would be a delightful and convenient idea to put a parking space right there outside the kitchen window, completing the rectangle by filling in the open space of the L alongside the "loggia." And wouldn't that be the cleverest thing, so useful for getting groceries into the kitchen in the fewest number of steps? So the inventive builder did just that, paved the front yard for a parking space.

You may wonder why anybody would want to look out the window and see a work truck in his front yard at the end of the day, especially his own. To prove I agree with you, I jackhammered the slab up after a week. The next idea by the same designer (?) was to plant a lawn in the spot, a little patch about the size of a green on a "pitch and putt" golf course. I did that, or rather had it done by a pro who hauled in matts of grass and installed an irrigation system.

Of course, weeds, and I mean hungry suckers, elbowed their way up through the tender new soil in between the blades of grass in no time, flattening anything that got in their way.

And guess who appeared looking over my shoulder every time I stood at the kitchen sink doing the dishes, gazing at my weed-lawn?

"Danny, time to get the weed done. Now."

That's right, him, the Ogre of

In terms of beauty, the only difference between a slab of concrete in the front yard and a patch of lawn the same size is that one is green and the other is grey.

I stood next to the young lady and introduced myself. She looked up at me with one of those smiles that makes you think you're somebody even though you don't know why. She sprang up, the trowel dangling from her hand, and looked at me straight in the eyes, which surprised me because I figured her as a petite woman, probably due to the yoga position in which I found her.

Nothing about Genevieve was petite.

I asked her if she knew someone who might be able to help me design a garden.

"Yes!" she exclaimed, putting down the trowel. "Can I see the area?"

I had some money to spend on the project, or thought I did. My most recent business statement indicated that I had a chunk of cash which I thought was mine not realizing that it had been put aside for taxes. So I spent the whole thing on the garden. My accountant, when he found out, asked me why did I do that? By then, of course, it was too late.

Would I have spent the tax dollars on making a garden if I had known the money wasn't mine? Well, I don't know. I was pretty desperate to remedy my failures. And although I ended up with a debt, I also ended up with something transformational.

They say beauty is in the eye of the beholder, but I disagree. If a beholder doesn't see the beauty that's right there in plain view, well, why is that? We humans are not that different. We all have the same teacher.

Nature. Nature is the one thing that belongs to all of us, no matter what culture or time. Nature is the primary agent of beauty. For

one thing, nature has a plan and it doesn't lie or go wrong. It can play tricks to get us to do things for our own survival, for example, line up mates for us who don't last.

But nature bats last, as they say and that is proved every time by the children who arrive whether from the matched or the unmatched to make the next generation. The children almost always end up being terrific offspring.

Meanwhile, nature calmly composes itself in the process of everything it creates if you give it enough time. Left alone, that is, without pesky human interference, practically every natural scene is beautiful, whether it's the sky, the landscape, or a clearing in a forest.

When we humans try to come up with a good design, if we follow nature's rules of composition, well we can't go wrong by definition. The beautiful will come about. Or at least, that has been my experience in the realm of buildings, when I have followed nature's principles (which of course, like everybody else, I often fail to do).

Over the next several weeks the former parking space/golf green got turned into Dan's "Garden of Eden," designed by Genevieve. Or as I prefer to call it, "Paradise Now." All it took (after removing the lawn) was a water element (bird bath), elevation changes by making hillocks, symmetry in the location of the shrubs, a bending pathway to soften the course of the eye while walking through the garden, and one big Maple tree in front to hold back the chi from running away and leaving me bereft of all its good energy. (A midwife friend who was visiting from England had told me that all the chi in my house was escaping every time I opened the front door because nothing stood in its way of it getting sucked down the hill and into the bay. The maple tree fixed that problem.)

Many of the principles of beauty found in garden design, I believe, are the same ones found in building design: symmetry, replication, careful attention to details, balance, elevation changes for the eye, plenty of exposure to

sunlight where needed, variation created by shadowing (tree limbs and leaf shapes in gardening) and many others.

Long ago when the planet was warming after the ice age, the hunter/gatherer peoples who came down from the north into the Fertile Crescent found what must have seemed to them a bounty beyond belief: rivers full of fish, forests full of game, meadows full of wild grains, flocks of birds filling the skies.

It is no wonder than this period has been deemed the Garden of Eden, for it truly was a paradise of the natural world.

Over time, the Natufian peoples settled in the area and planted grains (wheat and barley) to supplement the wild varieties of grasses which they could gather. Significantly, the Natufians also were the first culture to make permanent dwellings in which they could store their extra food for future supplies, indicating that they weren't planning to move.

The first sedentary villages appeared during this era. The simple life of the Natufian Culture in cooperation with nature was a natural solution to the insecurities of the migratory life they had lived during the Stone Age.

Though many today romanticize Nature, we cannot repeat the Age of Innocence. But we have our gardens to recreate, at least symbolically, something like what the Natufian Culture made in their world.

Several years after the garden Genevieve made for me had reached maturity, she remarked that a garden is the transition between one's house and nature. She is right. And since all three realms follow the same principles, we don't have to look far to see the extraordinary beauty emerging in each of the realms, whether in the house, the garden, or in nature.

One could even say that beauty is the thread that binds them all together, weaving its way along and making everything better.

that the City of Arcata City Council will conduct a Public Hearing on December 7, 2022, at 6:00 p.m. on the appeal of the Planning Commission's October 25, 2022, action to approve the proposed Planned Development Permit amendment, Tree Removal Permit, and Design Review Permit at 2351 Westwood Court, Arcata.

The City Council has returned to in-person hybrid meetings. Consistent with the February 28, 2022, issuance of Governor Newsom's Order No. N-5-22 and the California Department of Public Health's updated Guidance on the Use of Face Masks, the wearing of face masks is not required in City Hall but is strongly recommended.

The City Council asks that when attending meetings, persons socially distance as best as they can and be courteous to those who continue to wear a mask.

Project Description:

The City Council will consider an appeal of the Planning Commission's October 25, 2022, approval to develop 102 new, one bedroom dwelling units about 416 square feet in size on a 5.16 acre site known as the Westwood Garden Apartments (File No.: 212-027-PDP-TRP-DR). The site is currently developed with 60 dwelling units. The in-fill housing improvements include new or revised access, parking, laundry, solid waste, walkways, utilities, lighting, stormwater, and landscaping. Site development includes the removal of 21 trees: 10 trees greater than 16 inches in diameter (DBH); and 11 trees less than 16 inches in DBH. Janes Creek/McDaniel Slough is in the southern portion of the parcel. No development is proposed within the 100-year flood zone. Exceptions to the amount of private recreation area and yard setbacks were approved by the Planning Commission.
